BY-LAW NUMBER 2015-13

BEING A BY-LAW TO APPOINT MEMBERS TO THE CHAMPLAIN COMMITTEE OF ADJUSTMENT

REFERENCE: *Subsection 1 of Section 44 of the Planning Act, Chapter P.7, R.S.O. 1990*

WHEREAS the Council of The Corporation of the Township of Champlain, by its By-Law Number 2015-12, did establish a Committee of Adjustment;

AND WHEREAS Council now deems it necessary and expedient to appoint Members to the Champlain Committee of Adjustment;

NOW THEREFORE the Council of The Corporation of the Township of Champlain hereby enacts as follows:

1. **THAT** the Membership of the Champlain Committee of Adjustment shall consist of five (5) members only.
2. **THAT** the Members of the Champlain Committee of Adjustment for the four year term ending November 30, 2018 be as follows:

3. **THAT** By-Law 2011-04 be and is hereby repealed.
4. **THAT** this By-Law shall come into force and take effect upon its passing.

BY-LAW NUMBER 2015-12

BEING A BY-LAW TO ESTABLISH A COMMITTEE OF ADJUSTMENT FOR THE CORPORATION OF THE TOWNSHIP OF CHAMPLAIN

REFERENCE: Section 44 of the *Planning Act*, R.S.O. 1990, Chapter P. 13.

WHEREAS Subsection 44(1) of the *Planning Act*, states, inter alia, that the Council of a municipality may by by-law constitute and appoint a committee of adjustment for the municipality composed of such persons, not fewer than three (3), as a council considers advisable.


AND WHEREAS the Council of the Corporation of the Township of Champlain now deems it necessary and appropriate to establish a Committee of Adjustment;

NOW THEREFORE BE IT RESOLVED THAT the Council of The Corporation of the Township of Champlain hereby enacts as follows:

1. **THAT** a Committee of Adjustment be established and entitled "**Committee of Adjustment for the Township of Champlain**".
2. **THAT** the Committee of Adjustment shall be composed of members who are not members of the Municipal Council for the Township of Champlain and shall hold office concurrent with the term of Council.
3. **THAT** the composition of the Committee of Adjustment shall be composed of five (5) appointed non-elected members from the following wards:

Ward of Vankleek Hill	1 member
Ward of L'Orignal	1 member
Ward of Longueuil	1 member
Ward of West Hawkesbury	2 members
4. **THAT** the Secretary-Treasurer of the Committee of Adjustment for the Township of Champlain shall be the Clerk of The Corporation of the Township of Champlain;
5. **THAT** the remuneration of the Members of the Committee of Adjustment for The Township of Champlain, including the Secretary-Treasurer, shall be at the same rate as the remuneration of Members of Council for attendance at their respective committee meetings;
6. **THAT** the *Terms of Reference* listed in Schedule "A" of this by-law be approved by Council and amended as needed by resolution or by-law.
7. **THAT** this by-law shall come into force and take effect upon its passing.
8. **THAT** By-Law 98-07 is hereby repealed.

READ a first, second and third time and duly adopted this 11th day of February, 2015.
